\$65 Rebate on Epson Printers for StoreNext Dealers

August 26, 2007

StoreNext dealers can now receive a \$65-per-printer rebate on Epson 6000-III printers and a \$25 rebate on Epson single-station printers. This rebate offer is good on printers shipped through March of 2008 and retroactive rebates will be paid on orders placed as early as July 1, 2007.

Dealers will file for these rebates and receive them directly from Epson. StoreNext pricing and invoicing amounts will not be affected. Dealers will still use current StoreNext prices.

THE RULES

- The rebate amount is \$65 on all Epson 6000-III (MICR, no MICR, imaging, no imaging, flip, no flip) and \$25 on single-station printers such as the TM-88III. These rebate amounts are valid for purchase from StoreNext that do not include special deal pricing partially funded by Epson (there are none known at this time). If Epson-funded special deal pricing is in effect, the rebate amount will be reduced by the amount of Epson funding.
- Orders must have been placed on or after July 1, 2007 and rebate filings will be accepted retroactive to that date. Shipments must be complete prior to March 31, 2008.
- To file for the rebate, dealers must in all cases provide a copy to Epson of the StoreNext invoice as proof of purchase when the printers have been shipped and received. Dealers can submit these to Epson via e-mail, FAX or hard-copy.

- Confidentiality: Epson states that no Epson personnel other than the addressee above will see these invoices and all information provided by the dealer will be kept in strict confidence. StoreNext invoices provided as proof of purchase must show all dates, PINs and descriptions, the dealer name and ship-to address, the StoreNext dealer number and the StoreNext invoice number. Note however that Epson does *not* require the dealer's list or net pricing, the dealer's P.O. number for that order, or any customer information to be provided – these items may be blacked out on the invoice at the dealer's option.
- Rebate checks from Epson will be mailed to the dealer quarterly, approximately three to four weeks the quarter close (quarters end September 30, December 31 and March 31).
- This offer also assumes RSPA membership. If your dealership is not currently in RSPA, please e-mail [Tony van Seventer](mailto:Tony.van.Seventer) at StoreNext as soon as possible.
