Connected Payments Pricing Update

January 4, 2010 Issue 2

This Issue 2 adds the time limit of December 31, 2010 to receive the Pre-Licensed pricing offer. Changes of significance are noted in red.

StoreNext's Connected Payments special offer for pre-licensed users is being changed and brought into line with the MTXEPS policy.

As of January 1, 2010, pre-licensed users¹ will receive the Connected Payments Summit package for the Criterion package price for two (2) years, after which the subscription price will revert to the then-current subscription price for Summit. The date of record for starting the two-year clock is the anniversary date of the agreement (that is, the execution date, not the installation or hookup date).

StoreNext will continue to honor the "lifetime" pre-licensed discount on any new agreements received through December 2009. However, all paperwork **must have been completed** and the agreements executed by December 31, 2009.

Merchants who are already receiving the pre-licensed discount with the "lifetime" provision will continue to receive that discount through their current agreements and contiguous renewals.

The current pre-licensed offer (Summit for the Criterion price for two years) will continue to be available for new agreements through 2010. However, the pre-licensed offer will not be available for any new agreements after December 31, 2010. Of course, the terms of any agreements using the pre-licensed offer will remain in place, whether the lifetime or two-year version of the pre-licensed offer is in place.

Note that the currently available hard-copy brochures include a pricing summary sheet dated 04-08 that describes the former policy. Dealers must replace this previous sheet with the updated Connected Payments pricing sheet (attached) before providing these brochure packages to Connected Payments prospects. StoreNext is unable to honor orders or agreements specifying obsolete pricing, terms or conditions.



¹ "Pre-licensed" refers to those merchants who purchased a WinEPS license prior to October 1, 2007 and are switching to Connected Payments. Stores that have already received a pre-licensed subscription discount in the past are not eligible to receive a new pre-licensed discount after the expiration of the original discount period.

SPECIAL PRICING FOR SMALL STORES

- Stores with five or fewer lanes will receive a special discounted price
- Special small-store pricing is available for the Criterion package as well as the Summit package

SPECIAL PRICING FOR PRE-LICENSED SITES

Stores that were licensed for WinEPS software prior to October 1, 2007 can receive a special discount on the Summit package for the first two (2) years of a Connected Payments subscription

- Receive the Summit Package at the Criterion package price for two years: a 30% discount
- Offer expires: the Connected Payments Agreement must be executed by December 31, 2010. The special pre-licensed pricing offer will not be available for new agreements signed after that date.
